An audit also includes such test and other procedures as I/we consider necessary in the circumstances except as explained in the following paragraph.			
Due to the nature of the types of transactions inherent in an election campaign, it is impracticable through auditing procedures to determine that the accounting records include all donations of goods and services, receipts and disbursements for the campaign period.
