PART B – BIDDING PROCEDURES

Revise: B2.1 to read the Bid Submission deadline is 12:00 noon Winnipeg time, April 1, 2005.

Add: B9.2 The Bidder shall state a separate price in Canadian funds for each of the following items of Work on Form B: Prices:

- (a) Separate Price Item No. 1 shall be the unit price amount for each additional PCB containing ballast to be disposed of over the initial amount of 300 in accordance with Section 13085 of the Specifications;
- (b) Separate Price Item No. 2 shall be the unit price amount added to the lump sum price for each additional refill, flush and disposal of the cleaning solution in the brine piping in accordance with Section 13086 of the Specifications.

PART E - SPECIFICATIONS

Revise E4.1 to read: Contractor shall provide 24 hour building security from project award date to Total Performance Date.

Add E6 Brine Test Analysis

E6.1 – The Brine test analysis forms part of this specification for information purposes only.

Add E7 Light Fixture Count

E7.1 – The Light Fixture Count forms part of this specification for information purposes only.

Section 13080

Add 1.3.13 - PCB containing light ballasts estimated to be 300 in total. The Contractor is to dispose of these 300 PCB light ballasts in accordance with these specifications. These costs to be included in the total bid price on Form B-R1 prices.

Add 1.3.14 - Dispose of all PCB containing ballasts over the estimated count of 300. The Contractor is to provide a separate price item for each additional PCB ballast as a unit price in separate price Item 1 on Form B-R1 prices.

Section 13086

Add 1.2.7 - Contractor to refill and flush entire brine piping system, once brine solution drained, by pumping cleaning solution through entire system for a period of 3 hours. Remove and dispose of cleaning solution as contaminated material. Submit sample to certified laboratory for testing to meet approved safe levels for bring piping disposal.

Add 1.2.8 - Contractor to provide separate price item No. 2 as a unit price, for each additional refill, flush and disposal on Form B-R1 prices.
