PART D – SUPPLEMENTAL CONDITIONS

Add **D2.3** as follows:

D2.3 The successful Bidder for the consulting services for the preparation of a business plan will not be allowed to bid on the Request for Proposals for the **implementation of a 3-1-1 system.**

Delete: Clause **D11** in its entirety.

Add **D13.3** as follows:

D13.3 The City intends to award this Contract by January 27, 2006.

Add **D18.** as follows:

D18. DECLARATION OF NO CONFLICT

18.1 The Contractor hereby declares that this agreement is entered into in good faith on the part of the Contractor, that no member of City Council, administrative or financial officer, director, or any other member of the City has any pecuniary interest, direct or indirect, in this Agreement or any other Agreement or part of an Agreement, contract or commission made pursuant to this agreement or to any benefit to arise therefrom, and agrees that it shall forfeit all claims for payment or otherwise under this agreement if it shall appear that any member of City Council, administrative or financial officer, director or any other officer of the City is at any time interested therein or if any interest therein is given or agreed to be given to it and as well shall refund to the City any monies paid to the Contractor by the City under this agreement.

- 18.2 The Contractor declares that it has not participated in any collusive scheme or combine in connection with the Proposal or this agreement and agrees that it shall forfeit all claims for payment or otherwise under this agreement if it should ever be established that this declaration is false and as well shall refund to the City any monies paid to the Contractor by the City under this agreement.
- 18.3 The Contractor declares that it has no implementation agreement, affiliation, certification, or partnership with any potential ERP software provider, distributor or reseller or ERP software implementor or integrator and agrees that it shall forfeit all claims for payment or otherwise under this agreement if it should ever be established that this declaration is false and as well shall refund to the City any monies paid to the Contractor by the City under this agreement.
