Revise: D17.1(a) to read : (a) The Contractor shall complete the installation of the temporary pipe supports as noted in Item 6 of the construction sequence (Drawing WY-S0453) within fourteen (14) Calendar Days from the commencement of the Work noted in Item 6 but in no event later than September 29, 2006.

PART E - SPECIFICATIONS

Add: E14.7 Supply and install telephone services from the MTS pedestal to the relocated site office, four telephone lines and one fax line, install lines above grade attached to the chain link fence.

Section 03300

Add: 3.14.9 Water used for testing shall be subject to chlorine residual testing prior to disposal. The Contractor shall retain water in the Surge Tower as required to de-chlorinate to the satisfaction of the Contract Administrator.
