of the commencement of the Work as specified in D9.

Add: E2.2.2(g) All necessary permits and charges required to implement and complete the Work.

Revise: E3.2.11 to read: Nut Covers

The bolts shall be capped with a 1 inch plastic Nut Cover, grey in colour to match Pantone Colour System PMS 429C, as manufactured by Nova Pole International, 203, 26229 Township Road, Spruce Grove, Alberta. Attention: Sandra Atkins, Distributor.

Clarification of E3.5.3(c): Delete the last sentence, which reads, "Based on the weather conditions, the Contractor

shall temporarily restore the Site to the satisfaction of the Contract Administrator until

final restoration."

Add: E4.2.4 The Poles are to be supplied by the City of Winnipeg. The Poles are currently available

for pick-up at 1500 Plessis Road, Bridge Maintenance Yard. Contact the Contract

Administrator for site access.

Add: E4.2.5 Each pole is identified with a specific engraved Structure Number, (ex. WF001), which

corresponds to a specific Site location as specified in E2.3 Location. The poles are stored

on pallets in sequential order of installation.
