Revise: D2.2 to read: The major components of the Work include but are not limited to:

- (a) Supply and Installation of all masonry work including concrete masonry units, stone masonry units, metal fabrications, joint sealants at masonry work, steel doors and frames, coiling doors, glass and glazing;
- (b) Supply and Installation of all Metal Cladding, including aluminum cladding to columns and soffit areas, rough carpentry, self-adhering waterproofing, building insulations, air barriers, firestopping and smoke seals, joint sealants between metal cladding work and between metal cladding and other work;
- (c) Supply and Installation of aluminium curtain wall and entrances.
- (d) The City will apply and pay for the Building Permit. All other permits are the Contractor's responsibility.
