Revise: B2.1 to read: **The Submission Deadline is 4:00 p.m. Winnipeg Time, February 6, 2007.**

**PART D – SUPPLEMENTAL CONDITIONS**

Revise: D12.4.1 to read: If the Contractor is unable to perform on-site warranty services, the City of Winnipeg will provide the service at a rate of \$105.00 per hour which shall be billed to the Contractor over and above the warranty related costs.

Revise D12.7 to read: The Contractor shall authorize the City of Winnipeg Repair Facilities to perform minor warranty repairs and breakdowns during evenings, nights and weekends as required. The extent of the repairs shall be limited to a maximum of 4-hours per unit per breakdown. For all other warranty repairs, or warranty repairs requiring more than 4-hours labour, the City shall contact the Contractor the following business day. Any work performed by the City shall be charged to the Contractor at the Repair Facility's shop rate in effect at the time the work is performed (for example, shop rate for 2007: \$80.00/hour).
