### PART D – SUPPLEMENTAL CONDITIONS

Revise:	D2.2(b) to read:	Installation of new electric boilers, circulating pumps, expansion tank and heat exchanger. Note that boilers, pumps, expansion tank and heat exchanger will be supplied by others.
Delete:	D2.2(i):	Work shall also include any minor piping revisions required due to the temporary re- connection of the existing pool water heaters, and subsequent connection of the new boilers.
Delete:	D2.2(j)	Supply and installation of two (2) 125A 3P breakers in new Panel 101 for the temporary re-connection of the existing heating elements.
Delete:	D2.2(k)	The new temperature sensors and control schematic shall be connected and used to control pumps PU-1 and PU-2 as part of the temporary heating system as well as with the new boilers B-1 and B-2.
Delete:	D2.2(I)	Upon installation of new electric boilers B-1 and B-2, disconnect the existing heating elements from the 125A breakers and connect the new boilers to the 300A breakers. 125A breakers shall remain in Panel 101 as spares.
Revise:	D13.1(b) to read:	September 26, 2007 – pool heating system to be complete and operational;
Revise:	D13.1(c) to read:	September 18, 2007 – latest delivery date of new electric boilers (by others);
Delete:	D13.1(d);	November 19-21 – second shutdown period to allow for the installation of the new boilers.
Revise:	D14.1 to read:	The Contractor shall achieve Substantial Performance by November 21, 2007.
Revise:	D16.1(a) to read:	September 26, 2007 – pool heating system to be complete and operational – two hundred dollars (\$200);
Revise:	D20.1(a) to read:	80% payment on completion of Critical Stage D13.1(b);
Revise:	D20.1(b) to read:	20% payment on Total Performance;
Delete:	D20.1(c):	10% payment on Total Performance.

Delete:	1.3.4.1	Supply and install 2 new 125A 3P breakers in Panel 101 for the temporary connection of the existing heating elements.
Delete:	1.3.4.2	The 2 – 125A 3P breakers shall remain in Panel 101 as spare breakers on completion of the project.
Delete:	1.3.5.1	Temporarily connect the new feeders to the 2 – 125A 3P breakers to temporarily supply the 2 existing 100kW heating elements. Upon installation of the new boilers B-1 and B-2, disconnect the existing 100kW heating elements and connect the new feeders to the 2 – 300A 3P breakers and the new boilers.
Delete:	1.3.6.1	The new temperature sensors and control schematic shall be connected and used to control pumps PU-1 and PU-2 as part of the temporary heating system using the existing heating elements.
