Add: 24.1(c)

City of Winnipeg Water and Waste Department:

(i) Construction of Valve Chamber Modifications: Archibald Street and Doucet Street.

Revise:D15.1.2 to read:

Work on Marion and Archibald Street shall commence with the tie-in to the existing watermain on Archibald Street north of Marion Street.

(a) The tie-in of the watermain on Archibald Street north of Marion must be completed between 18:30 Friday and 06:00 Monday. Permanent pavement restorations must be completed during this same period, and the northbound lane reopened to traffic prior to 06:00 Monday. If permanent pavement restorations can not be completed during this period, the Contractor shall make and maintain temporary pavement restorations until the following weekend, and complete the permanent restorations between 18:30 Friday and 06:00 Monday.

Revise:D26.4(a) to read:

Archibald Street -

(i) South of Marion Street only the northbound curb lane may be closed to traffic. Two north bound lanes must be maintained to provide a north bound through lane and a left turn onto Marion Street. This shall be accomplished by shifting the north bound left turn lane onto the south bound centre lane and shifting the northbound through lane onto the north bound centre lane. Maintain a north bound right turn movement for automobiles and small trucks. South bound traffic will be limited to one south bound lane south of Marion Street.

- (ii) North of Marion Street one north bound lane must be maintained at all times, Monday 06:00 through Friday 18:30. South bound traffic will be limited to one south bound through lane and one south bound left turn lane on to Marion Street. The south bound centre lane adjacent to the left turn lane will be closed.
- (iii) The City of Winnipeg, Traffic Services Department will perform the following traffic signing at the Archibald Street and Marion Street intersection: placement of temporary regulatory signs, signage required for the diversion of traffic across the existing centreline, and signage for the modification or banning of any existing traffic movement through the intersection. The Traffic Services Department will require 48 hours notice for any changes required in signage.
