- (b) Fifteen percent (15%) of the Total Bid Price excluding item 1, upon completion of the exhaust work and testing for the first engine, Form 103 – Certificate of Equipment Satisfactory Performance executed.
- (c) Fifteen percent (15%) of the Total Bid Price excluding item 1, upon delivery of materials for the second engine, Form 100 Certificate of Equipment Delivery executed.
- (d) Fifteen percent (15%) of the Total Bid Price excluding item 1, upon completion of the exhaust work and testing for the second engine, Form 103 Certificate of Equipment Satisfactory Performance executed.
- (e) Fifteen percent (15%) of the Total Bid Price excluding item 1, upon delivery of materials for the third engine, Form 100 Certificate of Equipment Delivery executed.
- (f) Fifteen percent (15%) of the Total Bid Price excluding item 1, upon completion of the exhaust work and testing for the third engine, Form 103 Certificate of Equipment Satisfactory Performance executed.
- (g) Five percent (5%) of the Total Bid Price excluding item 1, upon issue of the Certificate of Substantial Performance.
- (h) Five percent (5%) of the Total Bid Price excluding item 1, upon issue of the Certificate of Total Performance.

#### PART E – SPECIFICATIONS

E9.4.1 Engine flexible connectors shall have stainless steel bellows and carbon steel ANSI 125/150 flanges.

E9.4.2 Exhaust pipe expansion joints shall have stainless steel bellows with carbon steel ANSI 125/150 flanges.

E9.4.3 All other material directly in contact with exhaust gases, except gaskets, shall be steel.

### **GENERAL CLARIFICATIONS**

- 1. The overhead crane will be available for use by the Contractor. The City will confirm that the crane is certified and will provide basic operating instructions prior to use by the Contractor.
- 2. Although labelling is not evident, the City has confirmed the possible existence of insulation suspected or known to contain asbestos material on the exhaust system piping of all engines. Form B Prices has been retained, subject to change based on further research by the City and a subsequent addendum.
