### PART E – SPECIFICATIONS

Revise E2.3 to read:

Item No. 2 – Commercial Modular Multi Gym Fitness Station (two stack), Vision Fitness model ST-710 or equivalent **in accordance with B5**, with the following features:

- (a) Frame
  - (i) Heavy duty frame to withstand continued usage of the unit in a high volume fitness room;
  - (ii) At minimum, the unit must have a lap pull down; low pulley row; cable column; and PEC Fly.
- (b) Warranty as follows:
  - (i) Lifetime on frame, weights, plates and guides;
  - (ii) Five (5) years on pulley, bearings and bushings;
  - (iii) One (1) year free labour.
