Failure to supply the sample unit(s) within the prescribed time interval stated in B9.4 may result in a failure to demonstrate, that he is

responsible and qualified to perform this contract.

Revise:: B9.8 to read: Should the Bidder not submit a sample that meets the approval of the Contract

Administrator, the bid may be determined to be non-responsive.

Revise: B9.9 to read: The Bidder shall be responsible for all freight costs associated with the delivery and

return of samples.

determined by using a Mitutoyo thickness Gauge (Model Number PD-0505).

responsible Bidder submitting the lowest evaluated responsive Bid for that section and shall have the right to choose the alternative which is in its best interests. If the Bidder has not bid on both alternatives or on all sections in Alternative 2, he shall have no claim against the City if his partial Bid is rejected in favour of an award of the Contract on the

basis of an alternative or section upon which he has not bid.
