SECTION 06 40 00 – ARCHITECTURAL WOODWORK

Revise 1.4.8 to read: "FSC Certified Wood: (Separate Price #1). Supply a minimum of 50% (by cost) of wood-based materials that are produced from FSC sources in accordance with LEED Materials and Resources Credit MR 7 – Certified Wood. Note that the party involved in final fabrication of millwork does not need FSC chain-of-custody certification, but all FSC certified material used must be sourced from an FSC chain-of-custody supplier.
