Form B(R1): Revise Spec Reference numbers for Item 4.3, and Items 9.1 through 9.10 inclusive.

Revise Description terminology in Item 9 to match Specification Section E10 (R1).

Revise Item 10.5 to read: "Bike Rack".

Revise Item 10.7 to read "'Jamison' Style Tree Grates incl. Galvanized Steel Support Angles".

Page numbering on some forms may be changed as a result.

.1 Contractor shall provide Mix Design Statement and supporting documentation that mix proportions selected will produce concrete of specified strength, air content and Workability. As part of submission, Contractor shall supply evidence that air-void system of the proposed mix design conforms to CSA Standard A23.1, Clause 14.3."

Add: E10.3.4 "Installation of Thin Set Unit Pavers on Vault Covers

- .1 Verify pre-cast concrete recesses scheduled to receive thin-set units have been finished with maximum permissible variation of 3 mm in 3049 mm from required plane and not more than 1.5 mm in 300 mm when measured from high points in surface.
- 2 Beginning of installation implies acceptance of existing conditions.
- .3 Clean surfaces which are to receive thin-set pavers to ensure removal of grease, oil and dust film.
- .4 Install materials to requirements of Terrazzo, Tile and Marble Association of Canada Installation Manual Specification Guide 09300, for exterior applications, maintaining uniform joint appearance with no cutting.
- .5 Set thin set units in place while bond coat is wet and tacky, prior to skinning over. Slide units back and forth to ensure a proper bond and level surface. Avoid slippage.
- .6 Clean backs of units and back butter to ensure a 95 % bond coverage.
- .7 Clean excess mortar from surface prior to final set.
- .8 Keep 2/3 of depth of grout joints free of setting material.
- .9 Allow proper setting time prior to grouting. Sound thin set units after setting materials have cured and replace hollow sounding units before grouting.
- .10 Force grout into joints to ensure dense finish. Remove excess.
- .11 Maximum variation in dimensions of paving may not exceed one-fourth of specified bed and joint width.
- .12 Clean paving as Work progresses."
