PART D – SUPPLEMENTAL CONDITIONS

- Revise: D11.3 to read: The City intends to award this Contract by June 23, 2010
- Revise: D12.1(a) to read: All Work at 590 St. Anne's Road, with the exception of the soil report which may be submitted up to 2 weeks following, shall be completed by July 21, 2010.
- Revise: D13.1 to read: With exception to the soil reports, which may be submitted up to 2 weeks following, the Contractor shall achieve Total Performance by August 4, 2010.

PART E - SPECIFICATIONS

Add: E1.2.4 to read: The following drawings are applicable to the work. The drawings are to be used for informational purposes only and should not negate the need for a site investigation. Drawings were printed between 1978-1985.

- Revise: E2.1 (a) (iv) to read: Removal and disposal of concrete fuel island and associated infrastructure including the complete removal of the curbing surrounding the elevated pad located above fuel tanks, and level to grade.
- Add: E2.1 (a) (xi) to read Removal and restoration of metal fencing as required. Fencing is located adjacent to the fuel site on the North side. For the purposes of bidding, assume that fifty (50) feet of fencing will be removed and replaced. Replace with existing fence if possible, or match

		new fence material to existing. For the purpose of bidding, assume that fifty (50 feet) of new fence material will be required to replace the fencing removed during Work. If at the time of Work this amount is deemed not to be required, it will be eliminated from the cost billed to the City.
Add:	E2.1 (a) (xii) to read	Removal of ABS piping as required. ABS piping is located on the boulevard facing Forrester Avenue on the opposing side of the existing metal fence. For the purposes of bidding, assume that all related ABS piping infrastructure will be removed. If at the time of Work this amount is deemed not to be required, it will be eliminated from the cost billed to the City.
Add:	E3.1 (a) (xi) to read	Removal and restoration of chain-link fencing as required. Fencing runs approximately South-East to North-West and is currently above existing fuel tanks. For the purposes of bidding, assume that fifty (50) feet of fencing will be removed and replaced. Replace with existing fence if possible, or match new fence material to existing. For the purpose of bidding, assume that fifty (50) feet of new fence material will be required to replace the chain-link fencing removed during Work. If at the time of Work this amount is deemed not to be required, it will be eliminated from the cost billed to the City.
Add:	E3.1 (a) (xii) to read	Removal of large wood loading dock as required. Wood loading dock is located approximately South-West of the fence on the opposing side of the existing chain-link fence. If at the time of Work this amount is deemed not to be required, it will be eliminated from the cost billed to the City.
