- Section 02445 3.1.1 Revise line to read: "Straight and true installation with 96mm spacing between pickets".

QUESTIONS

- 1. Who is responsible for supplying, installing cable & terminating the voice / data system?
 - Refer to section 16741, electrical contractor shall only provide raceway as indicated, Owner's forces to install cable and terminate.
- 2. Who is responsible for supplying, installing cable & terminating the TV cable system?
 - Refer to section 16741, electrical contractor shall only provide raceway as indicated, Owner's forces to install cable and terminate.

- Clarify what type & size of cabinets that are required for the voice / data system Drawing E2.2 note #7?
 Refer to section 16770, 2.1.4.7 the voice / data and sound system in the same cabinet.
- 4. Clarify what type or model # for the flush floor outlet that is required in room 113 lounge / day room.
 - Refer to section 16132, 2.5 floor outlets.
- 5. 200 Slab on grade is noted on drawing S1.1, but on structural detail drawing slab shows void form below. Please clarify if it is slab on void or slab on grade.
 - Slab on void
- 6. Will you require any type of waterproofing in the shower areas?
 - Yes, Kerdi waterproofing as per Addendum 2
- 7. Will you require the use of epoxy grout on any areas of this project?
 - No.
- 8. Are the exterior concrete roadway pavements per COW standard 3310 with a typical reinforcing mat or top and bottom steel as per the inside floor slabs?
 - Yes, exterior concrete roadway should be reinforced per COW standard 3310.
- 9. Are the exterior concrete sidewalks to be reinforced?
 - No.
- 10. Curbing is to be cast as integral or separate to the slab?
 - Separate to the slab.
- 11. How thick is the concrete in the parking lot and the concrete approach.
 - For the concrete parking lot the following structure will be used: 200mm Reinforced Concrete 75mm Base Course 300mm Sub Base Geotextile Fabric Compacted Subgrade
 - For the concrete approach, use the following structure:
 200mm Reinforced Concrete
 75mm Base Course
 375mm of 50mm limestone
 Geotextile
 Compacted Subrade

 - Concrete curbs to be constructed as per SD-200 Curb and Gutter
