Revise:	E5.5 a i) to read:	508 mm outside diameter steel pipe conforming to CW 2110
Revise:	E5.5 a ii) to read:	Minimum wall thickness: 7.1 mm
Add:	E5.6 c	Warning signs installed within the C.P. Rail right of way will be measured on a unit basis and paid for at the Contract Unit Price for "Rail Crossing Warning Signs". Number of units to be paid for will be the total number of warning signs supplied and installed in accordance with this specification, accepted and measured by Contract Administrator.
Add:	E5.9	The Contractor shall be responsible for coordinating his work with Manitoba Hydro. The Contractor is to have a Manitoba Hydro watch present during construction within the C.P. Rail Right of Way due to the close proximity of overhead hydro lines. The Contractor shall be responsible for any charges associated having a hydro watch on site.
Add:	E7.3	No additional payment shall be made for pipe and soil samples that are to be obtained by the Contractor. The unit price bid for the installation of "Watermain Renewals" shall include all work required to obtain the soil/pipe samples and provide them to the Contract Administrator in accordance with this specification.
