DESCRIPTION

- E35.11 Supply and installation of drain pipe will be measured and paid for at the contract unit price for "Drain pipe", measured as specified herein, which price shall be payment in full for supplying all materials and performing all operations herein described and all other items incidental to the Work included in this specification and as measured on site by the Contract Administrator.
- E35.12 Supply and installation of water pipe will be measured and paid for at the contract unit price for "Water pipe", measured as specified herein, which price shall be payment in full for supplying all materials and performing all operations herein described and all other items incidental to the Work included in this specification and as measured on site by the Contract Administrator.
