Revise: D2.2(a) to read: Construction of a cast-in-place concrete extension/addition to the existing Minnetonka

Chamber including the construction of a new manhole cast-in-place concrete base, pick-up and installation of steel thimbles and cast-iron sluice and flap gates and associated

hardware.

Revise: D2.2(e) to read: Supply and installation of a new manhole on the new manhole cast-in-place concrete

base

Add: D12.3(c)(xi) construct new manhole cast-in-place concrete base

Replace: Form I with the attached Form(s). The following is a summary of changes incorporated in the replacement

forms:

Form I(R1): New Item No. 8 is added and should read: Construction of new manhole cast-in-place

PART E - SPECIFICATIONS

Revise: E10.1(a) to read: This specification shall cover construction of cast-in-place concrete gate chambers,

including the construction of the cast-in-place manhole base, and removal and disposal of the existing manhole. This specification shall also supplement, revise and amend CW

2160.

Revise: E10.3(e) to read: Cast-in-place Concrete Chambers and Manhole Base Construction

(i) Construct cast-in-place concrete chambers including the cast-in-place concrete base in accordance with CW 2160, except as supplemented, revised or amended in this specification and as indicated in the construction notes on the Drawings.

- (ii) Adjust the location of reinforcing steel adjacent to openings to frame those openings in accordance with good practice, and maintain the bar spacing intent.
- (iii) Do not use welded splices for reinforcing steel.
- (iv) Order all wall reinforcing steel in lengths to best suit the spacing of walers so that reinforcing bars will not be bent or misformed in order to remove the walers.
- (v) Install foundation waterproofing in accordance with E12 of this Specification.
- (vi) The Contractor shall note that the existing gate chamber may not be vertical or plumb or square and may vary by +/- 150mm. It is the Contractor's responsibility to ensure smooth transition for the new chamber addition.
- (vii) The Contractor shall note that existing formwork may be present around the existing gate chamber and will have to be removed prior to placement of the gate chamber addition at the Contractor's expense.

Revise: E11.1(a) to read: This specification shall cover construction, supply and installation of a pre-cast concrete

manhole as shown on the Drawings.

Revise: E11.4 to read: Measurement and Payment

Supply and installation of pre-cast concrete manhole will not be measured and will be paid for at the Contract lump sum price for "Supply and install 1200 Diameter Manhole, and Associated Manhole Cover", which price shall be payment in full for supplying all materials and for performing all operations herein described, and all other items

incidental to the work.

Revise: E12.1(c) to read: The Contractor shall be solely responsible for all transportation to collect the two cast iron

sluices gate, two wall thimble, two mechanical lift operators, two stems, wall brackets and accessories after being notified by the Contract Administrator of their availability. The Contractor is advised that the wall thimbles will be available for pick-up the week of December 12, 2012, and all other mechanical hardware, such as cast iron sluice gate, mechanical lift operator, stem, wall brackets and accessories will be available for pick-up

from February 1, 2012.

Revise: E13.1(c) to read: The Contractor shall be solely responsible for all transportation to collect the two cast iron

flap gates, two wall thimbles, and accessories after being notified by the Contract Administrator of their availability. The Contractor is advised that the wall thimbles will be available for pick-up the week of December 12, 2012, and all other mechanical hardware, such as two cast iron flap gates, and accessories will be available for pick-up from

February 1, 2012.

Add: E24: SOILS INVESTIGATION REPORT

E24.1 Further to C3.1, of the General Conditions, several geotechnical soils investigations have been completed in the vicinity of the proposed works to determine the subsurface soils to facilitate the design of the Work. The information is considered accurate at the locations

indicated and at the time of the investigation. However, considerable variations in the soil conditions may exist between test holes (upper bank versus mid bank versus lower bank areas) and fluctuations in ground water levels can be expected seasonally, as the soils investigations were carried out a significant number of years ago. Test hole logs without reports are solely included.

- E24.2 Bidders are responsible for any interpretation they place on the supplied information in the test hole logs and are expected to make such additional investigation of the soil conditions as they feel necessary to satisfy themselves.
- E24.3 Any test borings made by the bidder shall be done in accordance with the requirements of the appropriate authority of the City of Winnipeg. Bidders shall notify the Contract Administrator prior to starting any soil boring operations.
