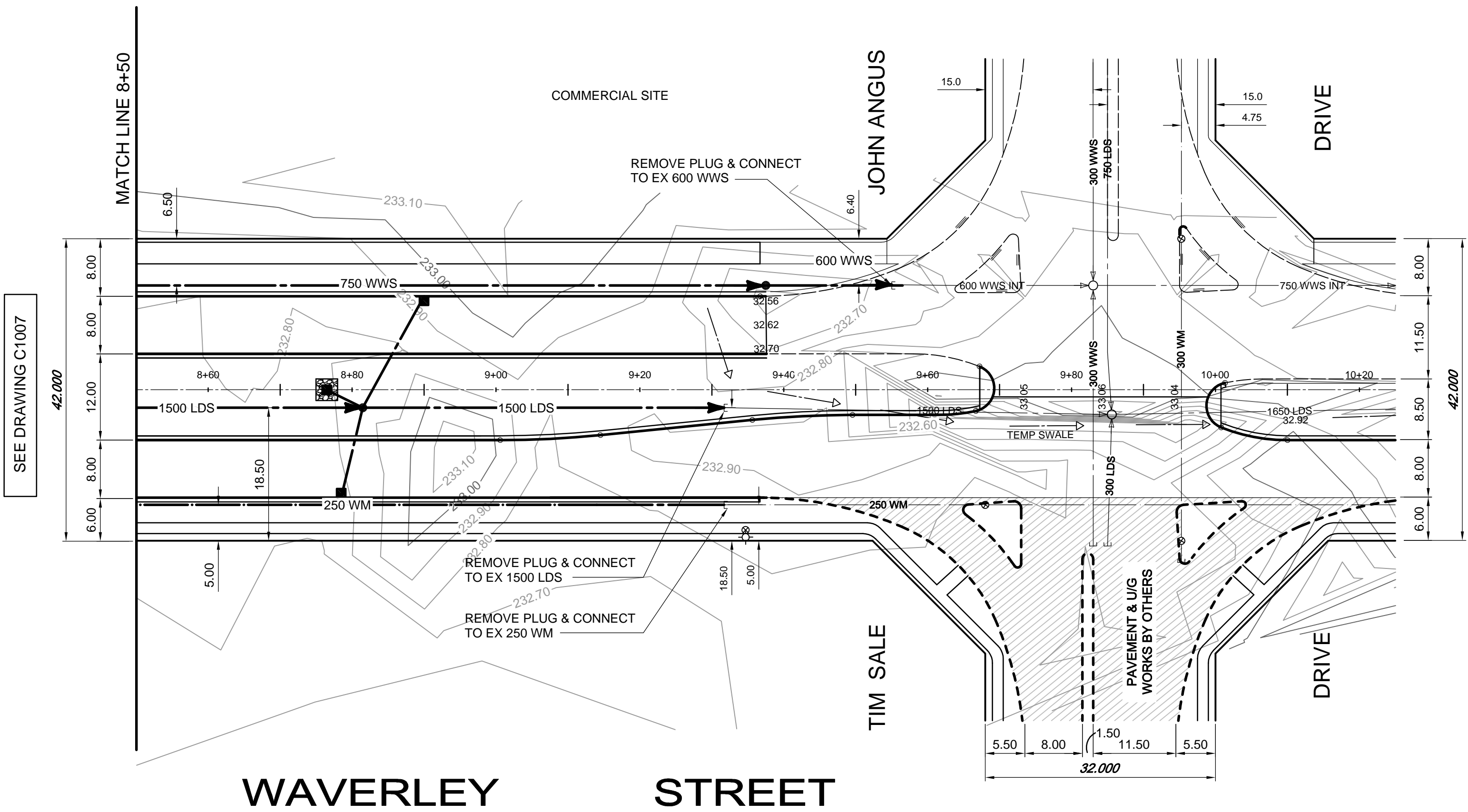

DWG NORTH



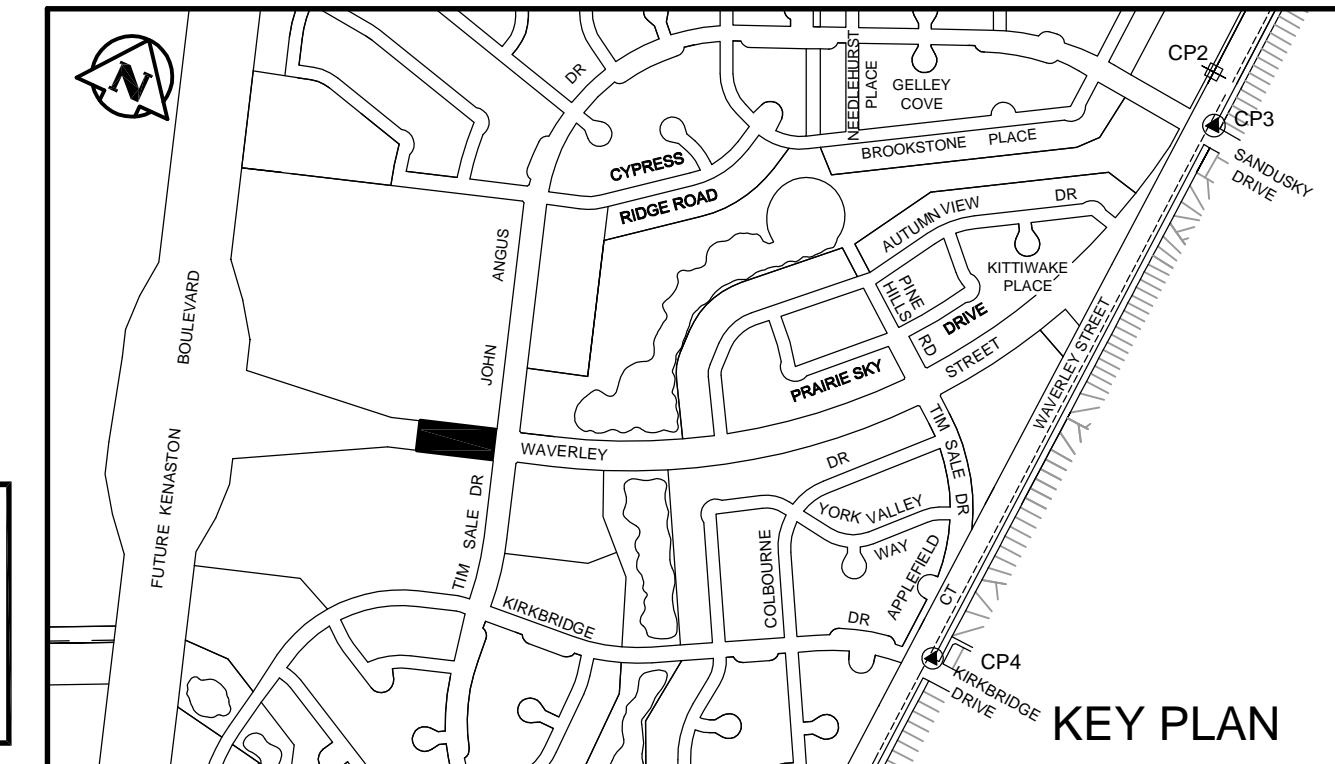

- CONSTRUCTION NOTES**
- ALL HYDRANTS AS PER SD-006.
 - ALL PAVEMENT DIMENSIONS ARE TO BACK OF CURB.
 - ALL BACKFILL UNDER BOULEVARD TO BE CLASS 4 UNLESS OTHERWISE NOTED.
 - ALL PIPE UNDER EXISTING AND FUTURE PAVEMENT TO BE INSTALLED USING TRENCHLESS METHODS, WHERE NOT POSSIBLE, OPEN CUT WITH CLASS 2 BACKFILL.
 - USE CLASS 2 BACKFILL WITHIN 3.0m OF NEW MANHOLE INSTALLATIONS.
 - THE LAST RISER SECTION ON ALL NEW MANHOLES TO BE A 300mm SECTION JUST BELOW THE FLAT TOP REDUCER FOR THE PURPOSE OF FUTURE ADJUSTMENT OF MANHOLES.
