Performance and shall expire two (2) years thereafter unless extended pursuant to C13.2.1 or C13.2.2, in which case it shall expire when provided for thereunder.

Add: E23.11 The estimated length of Corrugated Steel Pipe (CSP) listed in the Form B: Prices

includes the length of the culvert bevelled ends to the invert location.

Revise:E24.1 to read: This Specification covers the supply and installation of CSP culvert safety grates to be

installed on the bevelled inlet side of the 600 mm CSP culverts under Waverley Street as

located on the drawings and as directed by the Contract Administrator.
