The Contractor shall achieve Substantial Performance within forty-five (45) consecutive Working Days of the commencement of the Work as specified in D13 or by October 11, 2013, which ever occurs first.

Revise: D16.1 to read:

The Contractor shall achieve Total Performance within fifty-five (55) consecutive Working Days of the commencement of the Work as specified in D13 or by October 25, 2013, whichever occurs first.
