Revise: 5. Non Resident Contract Administration Fee Basis from "Fixed" to "Time-Based".

6. Resident Contract Administration Fee Basis from "Fixed" to "Time-Based".

PART B – BIDDING PROCEDURES

Revise B8.1 to read:

The Proponent shall complete Form B: Fees, making all required entries and summarizing all Fees for the Scope of Services.

- (a) The Proposal shall include a fixed fee for all disciplines, identified and necessary, for each Scope of Service phase of the Project listed in D4, with the exception of Resident and Non-Resident services, which will be time-based.
- (b) The Proposal shall include time-based fees for Resident Services. For proposal purposes these fees should be based on ten (10) hours per day for sixty (60) Calendar Days to achieve Substantial Performance. The proposed fee should include allowance for disbursements, including vehicle, electronic communication, etc. The actual working days will be established at time of tender will be with the consultation and concurrence of the Department.
- (c) The Proposal shall include time-based fees for Non-Resident Services. For proposal purposes these fees should be based upon twenty-five (25) hours per week for a period of ten (10) weeks to achieve Total Performance. The proposed fee should include allowance for disbursements, including vehicle, electronic communication, etc.

PART E - SCOPE OF SERVICES

Revise: E2.2 c) to read: It is expected that the HDD pipe installation will be a 24-hour, 7-day per week process,

and appropriate level of inspection service may be required.
