to read: Darco alarm panel for high and low level volume alert c/w tree kit and float switch in

underground tank. Alarm panel to be installed in trailer at kitchen counter, location to be

determined on site.

Add: E.8.7: The Contractor shall provide maintainenance of the shoring systems for the duration of

the Contract and up to one month following completion of the Work within this Contract to

facilitate transfer of the maintenance of shoring systems to the Contractor of a

subsequent SEWPCC project contract.

Add: E.8.8: Removal of shoring is excluded from the scope of the Work. Removal of shoring will be

performed by others in a subsequent SEWPCC project contract.

Add: E.8.9: Contractor shall coordinate shoring design with the Structural Designers to ensure that

the location of shoring elements such as rakers do not adversely interfere with building

construction in future contracts.

Add: E.9.10:

The Contractor shall be responsible for supplying and placing any granular working base deemed by the Contractor as necessary to facilitate access to their work required within the excavations. This includes any granular working base deemed necessary for the bottom of excavations or excavation ramps. The Contractor shall submit their plans for placement of granular base within the excavations with the Contract Administrator for approval prior to placement, in accordance with the submittal requirements of this Contract. The cost for any granular base for inside excavations or on excavation ramps shall be incidental to the cost of excavation work. No additional payment shall be made for granular material supplied and placed on excavation ramps or at bottom of excavations.
