PART B – BIDDING PROCEDURES

Revise: B15.1 to read: This Request for Proposal (RFP) has been developed for the City of Winnipeg by AECOM Canada Ltd. in response to identified needs for a Struvite Recovery System. The Struvite Recovery System forms a part of the Sewage Treatment Plant Upgrade and Expansion Program (the "Program") under which VVNA Winnipeg Inc. ("Veolia") provides advice and recommendations to the City on upgrades and capital modifications to the City's wastewater treatment facilities. A summary document of the program agreement signed on April 20, 2011 is currently available on the City Website at: <http://winnipeg.ca/waterandwaste/pdfs/sewage/treatmentPlantUpgradesAndExpansion/agreementSummary.pdf>. Accordingly, Veolia has provided advice and recommendations to the City on the development and consistency of this RFP to identify needs for a Struvite Recovery System for the Program. Bidders are advised that there is a possibility that a corporate affiliate of Veolia (an "Affiliate") might submit a Proposal in response to this RFP. In such circumstance Veolia will ensure that none of its personnel or any of its Integrated Affiliates' personnel who are involved in the Program will have any role whatsoever (whether directly or indirectly) with the development of the Affiliate's Proposal in response to this RFP. The City advises that in the event that a Veolia Affiliate submits a Proposal in response to this RFP, the City will ensure that none of Veolia's personnel or any of its Integrated Affiliate's personnel who are involved in the Program will have any role whatsoever (whether directly or indirectly) in the evaluation of the Proposals and recommendation for award of Contract pursuant to this RFP. It is the City's opinion based on the provisions of the Program Agreement and given the limited number of potential qualified Bidders for the Work of this RFP, that these circumstances do not create a conflict of interest or unfair advantage such that a Veolia Affiliate should be disqualified from submitting a Proposal or from an award of Contract pursuant to this RFP.

Add: B21.5.6(d) procure and install equipment that may not be identified by the Bidder but, in the City's opinion, may be required either at the time of initial installation or at some future date.

PART D – SUPPLEMENTAL CONDITIONS

Add: D2.1(o) "Affiliate" means, in respect of Veolia, such other corporation if one of them is the subsidiary of the other or both are subsidiaries of the same corporation or each of them is controlled by the same person, and if two bodies corporate are affiliated with the same corporation at the same time, they are deemed to be Affiliates of each other. For the purpose of this definition, a corporation is a "subsidiary" of another corporation if:

- (a) it is controlled by:
 - (i) such other corporation;
 - (ii) such other corporation and one or more corporations each of which is controlled by such other corporation; or
 - (iii) two or more corporations each of which is controlled by such other corporation; or
- (b) it is a subsidiary of a corporation that is a subsidiary of such other corporation.

Section 46 07 13 Packaged Struvite Recovery System

- Revise: 2.1.7.5 to read: Any product drying, classifying, handling, storage and bagging system required to meet the delivery conditions required under the Struvite purchase agreement.
- Revise: 2.5.1.3 to read: Product drying equipment to meet the delivery conditions required under the Struvite purchase agreement.
- Revise: 2.6.3 to read: The Bid Price shall be based on the Bidder's selected manufacturer(s).
