PART D - SUPPLEMENTAL CONDITIONS

Revise: D4.1 to read:

The Services required under this Contract shall consist of the full scope of architectural and engineering services required for the design and construction of a comprehensive scope of facility upgrades to the buildings in accordance with the following:

- (a) Pre-Design;
- (b) Schematic Design;
- (c) Design and Specification Development;
- (d) Contract Document Preparation;
- (e) Procurement Process;
- (f) Construction Services/Contract Administration; and
- (g) Post Construction Services.

D4.2 to read: Revise:

The project budget is currently \$2.5 million (\$1.25 million per library) inclusive of associated design and construction costs. Additionally there is a fund raising effort currently underway with the goal of raising an additional \$2.5 million for facility upgrades at both library sites however the total project budget will not be confirmed until June of 2015. As such a decision to proceed, or to not proceed, with the comprehensive scope of facility upgrades will not be made until after notice of award from The City authorizing the commencement of the Services. If at any time a decision to not proceed with the comprehensive scope of facility upgrades is made by The City, The City shall order a Change in Services with a resulting adjustment to the Contract (including, without limitation, a reduction to the Fixed Fee).

"Comprehensive Scope of Facility Upgrades" refers to the array of all facility D5.1(b):
