PART D - SUPPLEMENTAL CONDITIONS

Add to: D19.1:

- (b) Works on Osborne St. N/B & S/B Broadway to St. Mary Ave. are to be completed in 35 consecutive Working Days
- (c) Works on Sherbrook St. Ellice Ave. to Notre Dame Ave. are to be completed in 30 consecutive Working Days
- (d) Works on Ellice Ave. Balmoral St. to Maryland St. are to be completed in 20 consecutive Working Days
- (e) Works on Osborne St. Corydon Ave. to Don Ave. are to be completed in 25 consecutive Working Days

Replace D22.1(a) to read: Critical Stage – D19.1 (a) - Substantial Completion of Phase 2 by September 1, 2015 – Three Thousand Dollars (\$3,000.00) penalty per working day.

Replace D22.1 (b) to read: Critical Stage - D19.1 (b) - Substantial Completion of work on Osborne N/B and S/B from Broadway to St. Mary - Two Thousand Dollars (\$2,000.00) penalty per working day.

Replace D22.1 (c) to read: Critical Stage – D19.1 (c) - Substantial Completion of work on Sherbrook St. from Ellice Ave. to Notre Dame Ave. - Phase 2 - Two Thousand Dollars (\$2,000.00) penalty per working day.

Add D22.1 (d) to read: Critical Stage – D19.1 (d) - Substantial Completion of work on Ellice Ave. from Balmoral St. to Maryland St. – Two Thousand Dollars (\$2,000.00) penalty per working day.

Add D22.1 (e) to read: Critical Stage – D19.1 (e) - Substantial Completion of work on Osborne St. from Corydon Ave. to Don Ave. - Two Thousand Dollars (\$2,000.00) penalty per working day.

Revise E5.1.3 to read:

Maintain a minimum of two lanes northbound and one lane southbound on Osborne Street from Corydon Ave. to Don Ave. during the AM peak (7:00am to 9:00am). Maintain one lane northbound and two lanes southbound on Osborne Street from Corydon Ave. to Don Ave. during the PM peak (3:30pm to 5:30pm). Daily reversing of lane directions with appropriate signage is required. **Osborne St. – Corydon Ave. to Don Ave. must be completed one lane at a time**.
