

## DRAWING NOTES - PLUMBING

SUSPEND HOT WATER TANK AT HIGH LEVEL ABOVE MOP SINK & EXTEND T&P RELIEF TO MOP SINK. SUSPEND AS PER

PROVIDE NEW ACCESSIBLE ISOLATION VALVE (CURB STOP) BELOW FROST LINE FOR EXISTING 11/4" DOMESTIC WATER SERVICE. EXTEND NEW TYPE K COPPER LINE TO NEW UTILITY ROOM C/W ISOLATION VALVE. COORDINATE EXACT LOCATION ON SITE.

PROVIDE HOSE BIBB OR QUICK CONNECT TO PERMIT BLOW OUT OF

PROVIDE HOSE BIBB OR QUICK CONNECT TO PERMIT BLOW OUT OF WATER LINE IN AUTUMN. CONNECT BLOW OUT PIPE IMMEDIATELY DOWNSTREAM OF ISOLATION VALVE ON INCOMING WATER SERVICE. ALL TRAPS TO BE FILLED WITH ANITFREEZE DURING WINTERIZATION.

OFFSET VENT PIPE TO PENETRATE ROOF FROM CENTER OF



CONNECT NEW 4" SANITARY SEWER TO EXISTING SEWER IN EXISTING PIT. REFER TO ARCHITECTURAL DRAWINGS FOR LOATION OF EXISTING PIT

GENERAL CONTRACTOR TO COORDINATE RELOCATION OF EXISTING OWNER—SUPPLIED IRRIGATION EQUIPMENT CONTROLS FROM EXISTING WASHROOM BUILDING TO UTILITY ROOM IN NEW WASHROOM BUILDING. REFER TO ARCHITECTURAL DRAWINGS FOR DETAILS.

## DRAWING NOTES - H.V.A.C.

- SUSPEND EXHAUST FAN FROM STRUCTURE C/W ISOLATION AND FLEX CONNECTIONS.
- PROVIDE THERMAL INSULATION ALONG DUCT LENGTH AND PROVIDE BACK DRAFT DAMPER AT WALL LINE.

## GENERAL NOTES:

- 1. MECHANICAL SUBCONTRACTOR SHALL VERIFY EXACT LOCATIONS, SIZES, INVERTS, ETC. PRIOR TO COMMENCEMENT OF WORK. VERIFY ALL CONNECTION POINTS ON SITE.
- 2. MECHANICAL SUBCONTRACTOR SHALL ALLOW IN HIS TENDER QUOTATION FOR ALL REQUIRED MODIFICATIONS TO EXISTING SYSTEMS (I.E.) RE—ROUTING OF EXISTING PIPING AS DEEMED NECESSARY DUE TO RENOVATION WORK.
- REFER TO ARCHITECTURAL, ELECTRICAL & STRUCTURAL DRAWINGS FOR COORDINATION PURPOSES.
- 4. MANUFACTURED SHOCK ABSORBERS & PARTITION STOPS TO BE INSTALLED ON ALL FIXTURES OR BATTERY OF FIXTURES.
- 5. ALL CUTTING & PATCHING OF FLOOR SLABS, WALLS ETC. TO BE PERFORMED BY GENERAL CONTRACTOR.
- 6. ALL VENT PIPING TO BE INSTALLED AS PER CODE.
- 7. ALL DOMESTIC WATER LINES TO BE INSULATED.
- 8. COORDINATE THE EXACT LOCATION OF THE GRILLES AND DIFFUSERS ON SITE WITH THE ELECTRICAL SUBCONTRACTOR, GENERAL CONTRACTOR, ARCHITECTURAL CEILING PLAN, LIGHTING LAYOUT, ETC. TO ENSURE THAT THERE ARE NOT ANY CONFLICTS DURING INSTALLATION.
- 9. PROVIDE BALANCE DAMPER FOR EACH SUPPLY/EXHAUST AIR GRILLE OR DIFFUSER TO ALLOW FOR THE PROPER BALANCING OF THE SYSTEM. PROVIDE OPPOSED BLADE DAMPERS WITH THE DIFFUSER AND ADJUSTABLE FROM THE DIFFUSER FACE WHEN A DUCT MOUNTED BALANCE DAMPER WOULD NOT BE ACCESSIBLE.
- 10. ALL DUCT DIMENSIONS DENOTE INTERNAL "OPEN" AREA OF THE DUCT.
- 11. ALL DUCTWORK PENETRATING THE BUILDING THERMAL ENVELOPE SHALL BE INSULATED A MINIMUM 10'-0" BACK FROM THE BUILDING PENETRATION.
- 12. REFER TO ARCHITECTURAL DRAWINGS AND PROVIDE FIRE DAMPERS IN ALL WALLS DENOTED AS FIRE SEPARATIONS.
- 13. COORDINATE THE EXACT LOCATIONS OF EQUIPMENT, DUCT OPENINGS, AND DUCT LOCATIONS WITH THE EXISTING STRUCTURE AND THE CONTRACT ADMINISTRATOR.
- 14. ALL WORK SHALL COMPLY IN EVERY RESPECT WITH ALL NATIONAL, PROVINCIAL AND LOCAL CODES AND BY-LAWS, WHICH SHALL BE CONSIDERED PART OF THE SPECIFICATION. IN THE CASE OF CONFLICTING REQUIREMENTS, BE GOVERNED BY THE MOST STRINGENT REGULATIONS.
- 15. THE MECHANICAL SUBCONTRACTOR SHALL INSTALL PLUMBING, HEATING, AND VENTILATION, SYSTEMS IN COMPLETE ACCORDANCE WITH THE RECOMMENDATIONS OF THE NATIONAL/PROVINCIAL BUILDING CODE, ASHRAE, SMACNA LATEST EDITION DUCT STANDARDS, LOCAL PLUMBING CODES, AND DEPT. OF LABOUR REQUIREMENTS.
- 16. ALL INSULATING MATERIALS, METHODS, SIZES AND TYPES OF INSULATION FOR ALL PIPING AND DUCT WORK SHALL BE INSTALLED TO THE REQUIREMENTS OF THE ASHRAE STANDARDS 90.1 "ENERGY STANDARD FOR BUILDING EXCEPT LOW-RISE RESIDENTIAL BUILDING", AND THERMAL INSULATION ASSOCIATION OF CANADA (TIAC) STANDARDS.
- 18. LOCATE PLUMBING VENT THROUGH ROOF NEAR CENTER OF UTILITY CLOSET.
