Questions & Answers

- Q1 Does the City Own SRM licensing,
 - A1 Yes the City owns SRM licenses, the product is not in use, therefore no upgrade path is required.
 - (a) Unless however, it is part of something that we do use.
 - (b) We will consider the Vendor's Recommendation.
- Q2 Is the City interested is using newer BMC Toolsets?
 - A2 We don't know enough about the new toolset to make a judgment on suitability for our needs. We will consider the Vendor's Recommendation.
- Q3 Is it in scope to Upgrade ADDM?
 - A3 The City will update the ADDM as required and make it available for the vendor, It will the vendor's responsibility to integrate updated ADDM into Remedy.
- Q4 How much time is the norm for UAT?
 - A4 we don't have a norm, we want to be very thorough, 2 weeks seems reasonable,
- Q5 Do you Provide resources for the Testing

- A5 Yes, The City will provide Staff for UAT.
- Q6 Will we have a net new environment or the use the current Dev. environment?
 - We will look to the vendor for guidance, but we can provide a net new Environment if required.
- Q7 Do we need to have Dev. and Prod available at all times to the City
 - A7 Yes, PeopleSoft related updates are happening all the time
- Q8 Can we get a list of the Modules in use v/s what we're licensed for?
 - A8 Not at this time the vendor will need to rely on their own discovery.
- Q9 When do we want to start and finish by?
 - We are expecting a September Start and would like to finish before the new year, but understand it could go into 2017.
