Add: 1.1.7 No alterations are required to existing A/C or video display access area at the back of the

board. The existing air handling unit is expected to be reused for this installation. If there is the requirement to modify the A/C or access area, there shall be a Change in Work as

specified in the General Conditions for Construction C7 Changes in Work.

Revise: 1.2.1 to read: Existing Display Board – This section details the specifications of the removal and

disposal of the existing LED scoreboard located in the competition pool at Pan Am Pool.

This includes everything required to complete this removal.

Add: 1.10.1.1: The Contractor shall be responsible for structural modifications related to mounting and

anchoring of the new video display board. If extraneous structural issues are encountered or discovered during the structural engineering review there shall be a Change in Work as specified in the General Conditions for Construction C7, Changes in

Work, and costs shall be covered by the City of Winnipeg.

Add: 1.10.1.2: The existing power phase and amperage is shown on Construction Drawings AQ100 and

AQ102 as 208V 3PH 50Amp.

new Video Display.

Add: 2.1.11 Limited interruption in the existing Weight Room during construction can occur but

Contractor must provide specific dates and times to the Contract Administrator when

Work would be undertaken.

Revise: 2.2.1 to read: Base specified product for this project is a Video Display Board – Media Resources –

Vision IQ Video Display – Model #P10-RGB-672-416.

Revise: 3.0.7 to read: 2017 Canada Games – Provide technical support to City pool staff for four (4) days

duration on site during the Canada Games from July 27 to July 30, 2017. Contractor shall

provide a daily flat rate for this service. It would be expected the technical support be on

site for the preliminaries in the morning and the finals in the evening.
