PART E - SPECIFICATIONS

Revise: E2.9 to read:

The following requirements are specified per this Bid Opportunity, American Water Works Association (AWWA) C702 4.2.6 and AWWA M6.

- (a) The meter will perform to new meter accuracy standards, as specified in the table below, for a period of five (5) years after being installed by the City of Winnipeg;
- (b) Should a meter not perform as specified, the Contractor will replace the meter at no cost to the City of Winnipeg. A meter is not performing as specified if it fails to pass an accuracy test, conducted by the City of Winnipeg (or its chosen 3rd party) according to AWWA standards (for comparable meters). The specific required accuracy at given flow rates is provided in the table below. This requirement will not apply to meters that have been damaged due to abnormal circumstances.

Revise: E2.10 Meter accuracy must meet or exceed the requirements specified in this bid opportunity,

AWWA C702 4.2.6 and AWWA M6. Accuracy testing of each meter and display (register) must be performed. Each meter must be factory tested for accuracy of registration at flow rates and test quantities in accordance with section 4.2.6 of AWWA C702 and AWWA M6. The manufacturer must supply a certificate for each meter and display assembly

stating compliance with these accuracy requirements.

Revise: E2.11 Meters must be flanged per AWWA C702 4.3.3, as follows:

(a) 50mm Meters must be supplied with round flanges per AWWA C702 4.3.3.1.

(b) 80mm – 150mm Meters must be supplied with flanges per AWWA 702 4.3.3.2
