## PART B - BIDDING PROCEDURES

Add: B8.1.1 Fees for the portion of the Detailed Design phase, scope of work identified in D6.2 (h),

roadway rehabilitation design shall be broken out separately as they will be subject to results of the Preliminary Design road condition assessment and available budget

funding.

Add: B8.2.1 Fee schedule for the portion of the Contract Administration phase, scope of construction

work identified in D6.2 (h), roadway rehabilitation services shall be broken out separately as it will be subject to results of the Preliminary Design road condition assessment and

available budget funding.

## PART D - SUPPLEMENTARY CONDITIONS

Revise: D3.4 to read: At this location, Saskatchewan Avenue has two traffic lanes and no sidewalk, but there is

evidence of a well-used informal pathway on the South side of the road. Between Cavalier Street and Hamilton Avenue the road is in fair to poor condition and is slated for

rehabilitation.

Revise: D3.15 (f) to read: Construction starting in November 2017 and completed in October 2018.

Revise: D6.2 (c) to read: Raising of the approach grades and road reconstruction of Saskatchewan Avenue within

100m on each the West and East side of the new bridge.

Add: D6.2 (h) Roadway rehabilitation of Saskatchewan Avenue between Cavalier Street and Hamilton

Avenue outside the limits of the new bridge and 100m on each side of the new bridge,

but including the Cavalier Street and Hamilton Avenue intersections.

Revise: D7.3 to read: RESIDENT Contract Administration Services as defined in Appendix A necessary to

complete works of the project shall be provided. In accordance with Clause 7.5 of Appendix A, full-time inspection is required for the inspection of the bridge infrastructure. Fee estimates shall be based on a 12 month, November 2017 to October 2018, construction period. More specifically, fee estimates for roadway rehabilitation resident

services shall be based on a 30 day construction working day period.
