PART B – BIDDING PROCEDURES

Revise: B2.1 to read: The Submission Deadline is 12:00 noon Winnipeg time, August 31, 2017.

Add: B9.7 The Fees shall include a unit cost for the development of design specifications for each

recommended communication technology to be installed at one location of the City's

choosing.

Add: B9.7.1 A total of five (5) detail specifications with the same unit cost assigned to them

shall be assumed for each Fee Proposal.

Add: B9.7.2 This total number of specifications will be adjusted based on the final number of

recommendation technologies provided by the Consultant as part of the Study. Fees will be adjusted based on the actual number of design specifications

required using the provided unit cost per specification development.

Clarification of B9.7: It has been raised by Proponents that depending on the number of communication

technology recommendations provided, the level of effort in specification development can be dramatically changed. To address this a unit cost for the development of each specification has been requested as part of the Fee Proposal. This will allow for the Fees to be increased or reduced appropriately based on the actual number of recommended

technologies, and in turn level of effort required in specification development.

PART D - SUPPLEMENTAL CONDITIONS

Revise: D5.5(ii) to read: Design specifications for each recommended communications technology to be

installed at a specific site of the City's choosing.

Add: D5.5(iii) General Guidelines And Standards stating the requirements for the implementation of

each recommended technology, that are not specific to any one site, shall be included as

an Appendix to the study.

QUESTIONS AND ANSWERS

Q1 Under D5.3(c) of the RFP, should the recommendations include the associated upgrades required at the station?

- A1 Yes. Please include the general recommendations for what upgrades would be needed to accept the new communication technology, and meet current and future goals as defined in Appendix A.
- Q2 D5.4 is included under scope of services. Are there Contract Administration Services required by the consultant as part of this work?
 - A2 No. The City of Winnipeg will be assigned to coordinate all Contract Administration Services.
