PART A – PROPOSAL SUBMISSION

- Replace: 1248-2018 Form N with 1248-2018 Addendum 1 Form N (R1). The following is a summary of changes incorporated in the replacement Proposal Submission:
 - Form N (R1): Mandatory Requirements: Delete 9-1. Move content to Non Mandatory Requirements 24-1.

PART B – BIDDING PROCEDURES

Revise: B2.1 to read:

B2.1 The Submission Deadline is 12:00 noon Winnipeg time, June 11, 2019.

QUESTIONS AND ANSWERS

- Q1: Is there a viable chance we could win an RFP where there are mandatory requirements where we might need to say "No"?
 - A1: Generally, a bid cannot proceed if a proponent responds to a mandatory requirement with a no.
- Q2: Why are desired features of different types of products interspersed?
 - A2: The City of Winnipeg is looking for a tool that will best address a variety of public engagement needs across all city departments. As such, all required elements have been listed.
- Q3: Why is the relative weighting of requirements not transparent?
 - A3: Evaluation of the proposal is outlined in section B24.
- Q4: With respect to "Non-Mandatory Requirements" we'd like to understand the weighting system for these Requirements.
 - A4: The City will not disclose this information.

- Q5: On Form N is Respondent Registration going to be weighted 10 times more than 13-6?
 - A5: The City will not disclose the weighting system for these Requirements.
- Q6: Recognizing the City appears to have listed requirements for 2 very different types of online engagement products, that in our opinion complement each other more than complete, does this RFP allow for the City to acquire 2 offerings?
 - A6: The City is seeking to supplement its use of Survey Monkey and will acquire just one offering through the discussed RFP.
- Q7: While I'm based in Canada and will be leading this response, some of my extended team is in the US. This weekend is their Memorial Day Weekend. Would the City consider offering a one week extension on the proposal deadline?
 - A7: See Addendum 1.
- Q8: Section D2.8, the City States "In total, the pilot was responsible for 14 online surveys (nine in English and five in French) over seven different projects with a total of 13,887 survey participants. Can you clarify the amount of survey responses that the City of Winnipeg received from the 13,887 participants? For example: A) Was it 13,887 participants with 13,887 responses across 14 surveys? or B) Was it 13,887 participants with (eg 100,000 or higher) responses across 14 surveys?
 - A8: There were 13,887 responses across 14 surveys during the pilot.
- Q9: Will the City disqualify a respondent if their model did not meet a small subset of of the mandatories exactly? For example, would the City disqualify a respondent if they had a license model which had a limit on responses?
 - A9: If a mandatory requirement is not met, the proponent will be non-compliant with the requirements of the project.
