| Add:    | D10.1 (d):         | Contractor's pollution liability insurance in the amount of at least two million dollar (\$2,000,000) per occurrence and five million dollars (\$5,000,000) in the aggregate insuring against claims covering third party property damage claims and including clean-<br>up costs as a result of pollution conditions arising suddenly or gradually from the Contractor's operations and completed operations. Such policy shall include The City of Winnipeg and Canadian Pacific Railway, their employees, servants, and agents, as additional insureds and include a cross liability clause and remain in place for a minimum of twelve (12) months following Total Performance. |

#### PART E - SPECIFICATIONS

Revise: E12.11.2 to read: All reinforcing steel shall conform to the requirements of CSA Standard G30.18, Grade 400 W, Billet-Steel Bars for Concrete Reinforcement. All reinforcing steel shall be new deformed billet steel bars.

Revise: E12.12.1 to read: Anchor bolts, nuts and washers shall be stainless steel full length. The threaded portion of the anchor bolts shall be sufficient to install the lower gate rollers. Anchor bolt supply and installation will be incidental to construction of concrete pile foundations and no separate payment will be made.
