	E17.1.1	Provide all labour, materials, methods, equipment and accessories for the supply and installation of unit paving as indicated on the Drawings.

	E17.4	Construction Method
	E17.4.1	Contractor to verify the exact dimensions of unit pavers, brick pavers and stockpiled unit pavers, prior to the construction of blockouts in concrete sidewalk. Contractor to use physical samples of specified pavers when construction form work for blockouts.
	E17.4.2	Install concrete sidewalk w/ blockouts, and roadway w/ blockouts as specified on Drawings.
	E17.4.3	Preparation of Sand Base
	E17.4.3 (a)	Remove all accumulated debris from blockouts.
	E17.4.3 (b)	Install bedding sand to the depths indicated on the Drawings and to CW3330.
	E17.4.3 (c)	Do not compact sand base prior to installing pavers.
	E17.4.5	Installation of Unit Pavers
	E17.4.5 (a)	Unit pavers shall be installed in formed concrete blockouts and compacted subgrade in accordance with the specification CW3330 and CW3335, set in locations and patterns as shown on the Drawings. Spaces between joints shall be 5mm maximum and shall be uniform and consistent while maintaining true patterns as indicated on the Drawings.
	E17.4.5 (b)	Commence installation of pavers against edge to obtain straightest possible course for installation.
	E17.4.5 (c)	Pavers shall be cut with saw only to obtain true even undamaged edges. Chipped pavers are unacceptable.
	E17.4.5 (d)	Crews shall work on installed pavers, not on sand layer.
	E17.4.5 (e)	Place bedding sand over concrete and level.
	E17.4.5 (f)	Place pavers and spread and fine grade joint sand over paving surfaceand sweep into joints.

- E17.4.5 (g) Sweep remaining sand over all paving areas and remove from site.
- E17.4.5 (h) Replace at no extra cost all whole or cut stones marked as unacceptable.
- Remove cracked, chipped, broken or otherwise damaged paving materials from Site E17.4.5 (i) immediately.
- Upon completion, clean in accordance with manufacturers recommendations. E17.4.5 (j)
- E17.5 **Quality Assurance**
- E17.5.1 All workmanship and all materials furnished and supplied under this Specification are subject to close and systematic inspection and testing by the Contract Administrator including all operations, from the selection and production of materials, through to final acceptance of the Work. The Contractor shall be wholly responsible for the control of all operations incidental thereto notwithstanding any inspection of approval that may have been previously given. The Contract Administrator reserves the right to reject any materials or works that are not in accordance with the requirements of this specification.
- E17.6 Measurement and Payment
- E17.6.1 Unit Pavers will be measured on an area basis and will be paid for at the Contract Unit Price per square. The area to be paid for shall be the total installed area of unit paving accepted and measured by the Contract Administrator. Inclusive of bedding sand and joint sand.
- E18 Pruning of Existing Trees
 - E18.1 Description
 - E18.1.1 Provide all labour, materials, methods, equipment and accessories for pruning of existing trees within the limit of Work.
 - E18.2 **Quality Assurance**
 - E18.2.1 Pruning shall be provided by a person with a Manitoba Arborists Certificate with demonstrable experience sourcing and Work.
 - E18.3 Pruning Methodology
 - E18.3.1 Prune horizontal and vertical within the limits of construction to ensure construction equipment can be operated without interfering with trees to remain.
 - E18.3.2 Prune horizontal and vertical within the limits of construction to ensure clear walking path for pedestrians.
 - E18.3.3 Prune as required to remove dead, broken or damaged limbs.
 - E18.3.4 Prune back to healthy growth while maintaining balanced crown shape.
 - E18.3.5 Employ clean sharp tools.
 - E18.3.6 Make cuts smooth and flush with outer edge of branch collar near the main stem or branch.
 - E18.3.7 Cuts must be smooth and sloping to prevent accumulation of water on cut.
 - E18.3.8 Do not leave little stumps ("horns") on trunks or main branches.
 - E18.3.9 D39.3.8 Prune according to accepted horticultural practices as outline in "The Pruning Manual", Publication No. 1505-1977 by Agriculture Canada.

- E18.4.1 Pruning of Existing Trees will be measured on a lump sum basis and paid for at the Contract Unit Price for the "Pruning of Existing Trees". The lump sum price will be for the total number of trees pruned on Henlow Bay from Scurfield Blvd to Fultz Blvd in accordance with this specification, approved by the Contract Administrator..
