PART E - SPECIFICATIONS

Add: E5.3(b) The Contractor shall submit drawings sealed by a Professional Engineer registered in the

Province of Manitoba detailing the Contractor's proposed scaffolding, platforms, and swingstages to be employed. All scaffolding, platforms, and swingstages shall be designed, constructed, erected and operated in accordance with Workplace Safety and Health Division requirements. No Works shall commence without prior written approval of

the Contract Administrator.

Add: E6.3.3(c) The Contractor shall submit drawings sealed by a Professional Engineer registered in the

Province of Manitoba detailing the Contractor's proposed scaffolding, platforms, and swingstages to be employed. All scaffolding, platforms, and swingstages shall be designed, constructed, erected and operated in accordance with Workplace Safety and Health Division requirements. No Works shall commence without prior written approval of

the Contract Administrator.

Revise: E7.5.9(a)(iii) to read: Remove all existing copper metallizing coating by grinding, chipping prying, abrasive

blasting, or other means as approved by the Contract Administrator. Where the existing

copper metallizing is fully intact, it is a minimum thickness of 120 mils.

Revise: E7.5.17(e) to read: The personnel managing the QC Program shall provide evidence of successful

inspection of three (3) projects of similar or greater complexity and scope completed in the last two (2) years. References shall include the name, address, and telephone

number of a contact person employed by the facility owner.

Revise: E10.6.3(a) to read: Supply and fabricate new HSS section, new connection plates and new keys. Welding

shall conform to the requirements of CSA W59 Welded Steel Construction.

Revise: E10.6.4(b) to read: Connect all steel to wooden slats using new galvanized lag bolts.

Revise: E10.6.4(d) to read: Connect refurbished bench to limestone and HSS section with galvanized threaded

anchor rods, washers, nuts and Drop-In threads anchors.
