Replace: B10.1

B10.1 The Proponent shall state a price in Canadian funds for each item of the Work identified on Form B: Prices. The Proponent shall provide a detailed itemised cost breakdown as an attachment for all the included components of the proposed solution for each item on Form B: Prices. For example:

- (a) Final purchase, deployment, subscription and support cost.
 - (i) include detailed breakdown of items (including hardware and software)
 - (ii) Services for installation assistance (including ingestion of all data sources)
- (b) Total cost of professional services
 - (i) Design & specification/requirements gathering and documentation
 - (ii) SIEM tuning and system customization
 - (iii) Testing and Go-Live
 - (iv) Project Management
 - (v) Travel Costs & Living Expenses
- (c) Total cost of software
 - (i) Licensing/Subscription (including any third party software licenses)
- (d) Cost of instructor led training for approximately 5 Administrators (configuration & administration).

Revise: B23.6 to read: Further to B23.1(e), the Total Bid Price shall be the sum of the quantities multiplied by the unit prices for each item shown on Form B: Prices.

Revise: B23.8 to read: Further to B23.1(f), Experience of Proponent and Subcontractors will be evaluated considering the experience of the organization on projects of similar size and complexity as well as other information requested, in accordance with B11.

- Revise: B23.9 to read: Further to B23.1(g), Experience of Key Personnel Assigned to the Project will be evaluated considering the experience and qualifications of the Key Personnel and Subcontractor personnel on Projects of comparable size and complexity, in accordance with B12.
- Revise: B23.10 to read: Further to B23.1(h), Project Understanding and Methodology will be evaluated considering your firm's understanding of the City's Project, project management approach and team organization, in accordance with B13.
- Revise: B23.11 to read: Further to B23.1(i), Technical Requirements will be evaluated considering the Proponent's ability to comply with the requirements of the Project, in accordance with B14.
- Revise: B23.12 to read: Notwithstanding B23.1(f) to B23.1(i), where Proponents fail to provide a response to B8.2(a) to B8.2(d), the score of zero may be assigned to the incomplete part of the response.
