PART B - BIDDING PROCEDURES

Revise: B6.5 to read: Proposal format, including size of pages and font, etc., will not be regulated, except that

the Proposal should contain a table of contents, page numbering and should be in the Sections identified above. Proponents are encouraged to use their creativity to submit a Proposal which provides the requested information for evaluation and other information which illustrates the strength of their design approach, team, and project implementation strategy. The proposal should be limited to 18 pages, exclusive of the required forms, tables, charts, schedules, and reference information included in the Appendices, and exclusive of optional images or figures that the proponent may wish to include as an

appendix.

PART D - SUPPLEMENTAL CONDITIONS

Add: D5.9(a) The Heritage Resource Impact Assessment should include a systematic surface

inspection of the eroding bank, and judgemental testing of the lower bench.

Add: D5.10.1 Design for Active Transportation Path and connections to existing sidewalks and paths

should be included in the Preliminary Design Report and associated plans.

Add: D6.5 The Active Transportation Path will not be included in the tender documents.

Revise: D5.4(b) to read: Evaluate condition and extents of existing riprap erosion protection in particular at

locations where ongoing scour is apparent.

Revise: D6.4(d) to read: Assess impacts to channel hydraulics including water levels, flow velocities that may

result from the works, and provide recommendations to mitigate unacceptable impacts.

Revise: D11.2(c)(i) to read: an amount not less than \$ 2,000,000 per claim and \$ 2,000,000 in the aggregate

Revise: D13.1(b) to read: March 31, 2021: Complete construction (Substantial Performance), as-built surveys and

drawings

QUESTIONS AND ANSWERS

Q1: Will the existing HEC-RAS model be provided to the successful proponent?
