service (both sections are wavelength services or both sections are managed dark fibre

services but not wavelength service and managed dark fibre service).

award of Contract.

Revise: D18.2 Further to D18.1, in the event that the obligations in D18 apply, actual costs legitimately

incurred by the Contractor as a direct result of these obligations ("Funding Costs") shall be determined by the actual cost to the Contractor and not by the valuation method(s) outlined in C7.4. In all other respects Funding Costs will be processed in accordance with

Changes in Work under C7.

Add: D18.8 The City does not anticipate any Third Party Agreements for funding of this Contract.

Revise:	E2.1	Managed dark fibre services is an approved alternative for where wavelength services are referenced unless otherwise noted. The wavelength services or managed dark fibre services for inter-data center connectivity shall have the following specifications:
Revise:	E2.1(i)	shall terminate at each endpoint in a fiber optic Ethernet port (for wavelength services) or fiber optic patch panel (for managed dark fibre services) for handoff to the City's networks.
Revise:	E2.1(g)	Wavelength services (not applicable to managed dark fibre) shall pass the following acceptance tests:
Add	E2.1(J)	Managed dark fibre services (not applicable to wavelength services) shall pass a minimum 24 hour bit error rate test with no errors. The total optical loss budget shall be less than 5 dBm between the locations specified in E2.1(a).
Add:	E2.6	The Contractor's fibre optic cabling in public right-of-way shall be in conduit that is a minimum of one meter below the surface. A conductive marker tape should be buried above the conduit to assist in future cable location. Conductive tape to be detectable should be no more than 300mm (12 inches) below the surface.
Add	E2.7	The Contractor shall provide locate services for their fibre plant and should be a member of Click Before You Dig MB.
Revise:	E3.2	Item No. 1– Wavelength services or managed dark fibre (linear) shall be either quantity two (2) of 10 Gbps full duplex Point-to-Point wavelength connection service or minimum of 4 strands of managed dark fibre between 510 Main Street and 700 Assiniboine Park Drive with the specifications as described in E2 for use by the City of Winnipeg.
