PART B – BIDDING PROCEDURES

Revise B11.2 (f) to read: **(f) reference information:**

- i. Investigative/Forensic services: one (1) current name with telephone number per engagement, including business sector and approximate size
- ii. Performance Audit services: Two (2) current names with telephone numbers per engagement, including business sector and approximate size

Revise B13.3 to read: The Contractor shall not **begin** any Work until final approval has been given by the Contract

Administrator, or designate in writing.

Revise B22.1 to read: **Proposals shall be evaluated** based on the following evaluation criteria:

Revise B22.12 to read: **Contracts** will be awarded by item, to multiple Proponents on a call out-basis.

Replace B23.1, B23.2 and B23.2.1 to read:

B23.1 This Contract will be awarded by item, to multiple Proponents on a call-out basis. Further to B22.13 and B13, when investigative, forensic or performance audit services are required, the

City shall contact the qualified Proponent whose Proposal was evaluated the most advantageous pursuant to B22 and provide a detailed scope of service for that particular engagement in order to confirm that Proponent's capability of performing the required Services. The Proponent shall respond and either confirm its ability to supply such Services and provide written details of any and all requirements required by the City to execute the engagement including, but not limited to engagement plan, time line, proposed budget, and applicable fees (calculated pursuant to the Proponent's Form B Prices), or shall indicate it is not available to supply such Services, in which case the City shall contact the next most advantageous Proponent, who shall supply the same information, or otherwise indicate its unavailability, and so on until the City has received confirmation from a Proponent that it has the availability to supply such Services. The City and Proponent who shall Supply such Services shall execute a Statement of Work for same in the form attached as Appendix A – Statement of Work to this Request for Proposals.

PART E - SPECIFICATIONS

Revise E2.2 to read: Qualified resources are required for service delivery. If the Contractor provides

resources from another jurisdiction, the Contractor will incur all travel expenses. Depending upon the particular engagement, the City may require the firm's qualified resource to attend City of Winnipeg facilities as part of the engagement.

Revise E2.5 (a) to read: (a) Hold a CFE or CPA, CFF designation.

QUESTIONS AND ANSWERS

Q1: Will CoW accept a single client reference contact point for each Forensic Investigations project?

A1: See revision above regarding B11.2 (f).

Q2: Please confirm how many successful bidders under each work stream will be awarded contracts.

A2: The bids will be evaluated and ranked based on experience and price. Contracts will be awarded on an as required basis - there is no limit to the number of proponents on the call out list.

Q3: Will the CoW confirm that any proposed resources located in other jurisdictions will be compliant in meeting this requirement provided that all travel costs associated with travel to/from Winnipeg will be borne by the proponent?

A3: See revision above regarding E2.2

Q4: Will the CoW please define the minimum requirements for the number and resource levels of proposed "Key Personnel" required for evaluation purposes?

A4: Key Personnel are as defined on Form B.

Q5: Can the CoW confirm proponents are to include partners and owners within the three resource levels outlined in Form B.

A5: Proponents are requested to submit qualified resources at the three defined experience levels. Those years of experience levels are considered the minimum to be qualified; resources may have more years' of experience than the stated minimum.

Q5: Will CoW accept a single client reference contact point for each investigative/forensic project?

A6: See revision above regarding B11.2 (f).

Q6: Subject to the timely issuance of the CoW's responses to questions submitted, we respectfully request the proposal deadline be extended to December 1, 2020.

A7: At this point in time, the deadline will remain at noon (Winnipeg time) on November 17, 2020.

Q7: Who has the CoW used in the past five years to conduct Forensic Investigations and Performance Audits?

A8: The majority of Forensic Investigations and Performance Audits have been completed in house. All previous Audit reports are available at: https://winnipeg.ca/audit/reports.stm#tab-AuditReports

Q11: Can the CoW please confirm whether proponents will be able to submit a proposal that provides a response to only one of the two streams?

A11: Yes, that is correct.

Q12: We respectfully request clarification as to how the CoW plans on issuing call-ups in a fair manner based on the overall ranking of the bidders?

A12: The proposal will be evaluated based on experience and price. The Work will be arranged on an "as required" basis and will be based on experience, price and availability. See revision to B23.1 above.
