PART E – SPECIFICATIONS

Revise: E13.10 to read: Construction of temporary asphalt pavement shall be measured on an area basis and paid for at the Contract Unit Price per square metre of “Construction of Temporary Asphalt Pavement”. The area to be paid for shall be the total square meters of temporary asphalt pavement constructed accordance with this specification (E13.3 to E13.8), accepted and measured by the Contract Administrator. **All construction items included in E13.3 to E13.8 are considered incidental to “Construction of Temporary Asphalt Pavement” and no additional payment will be made.**

Revise: E13.11 to read: Removal of temporary asphalt pavement shall be measured on an area basis and paid for at the Contract Unit Price per square metre of “Pavement Removal, Temporary Asphalt Pavement”. The area to be paid for shall be the total square meters of temporary asphalt pavement removed in accordance with this specification (E13.9), accepted and measured by the Contract Administrator. **All construction items included in E13.9 are considered incidental to “Pavement Removal, Temporary Asphalt Pavement” and no additional payment will be made.**
