#### QUESTIONS AND ANSWERS

Q1: Is there a distinct difference between the future densification clause D7.12.12 (a) and the future design horizon of 35 years (D7.12.5)?

A1: Future design horizon refers to the growth projection for the next 35 years, while future densification refers to the increased in density. The future design horizon of 35 years is included in the solution design in the 60% draft Preliminary Design Report, the impact assessment of densification is a step after the solution 60% design.
