PART D - SUPPLEMENTAL CONDITIONS

Revise: D5.2 to read: For each phase identified in D5.1(c), subsequent stages will be negotiated with the successful proponent during the next years for the following services that will be required.

QUESTIONS AND ANSWERS

Q1: Is the City of Winnipeg going to clean each section of the floor before the Consultant does the assessment?

A1: No. Winnipeg Transit runs a street sweeper every morning, but it may not provide the appropriate cleanliness needed for the floor condition assessment. The proponent should assess and include the floor cleaning as part of their proposal, if required.

Q2: How many bus tracks will be available at the same time for the Consultants to do the concrete floor condition assessment?

A2: The availability of the tracks must be coordinated with Winnipeg Transit at least 24 hours in advance. For the purpose of this project, consider that no more than 2 (two) full tracks will be available for the Consultants at the same time. Be aware that each bay at the storage tracks consists of 12 tracks, and each overhead door opens two tracks. For example, tracks 5 and 6 in Storage Bay 2 are two different tracks although they share the same overhead door.
