The following is a summary of changes incorporated in the replacement Form A: Bid/Proposal:

- Form A(R1): Change in Paragraph 11
- 11. Time This offer shall be open for acceptance, binding and irrevocable for a period of <u>one hundred</u> <u>sixty eight (168)</u> Calendar Days following the Submission Deadline.

QUESTIONS AND ANSWERS

- Q1: I may have missed this in the tender, but what is the project schedule Evaluation, Award, Project Start dates, and expected completion?
 - A1: Refer to Form A (R1) Paragraph 11, The City intends to award the contract by March 31, 2022. Further to B13.5 and B13.6, the project schedule will be based on the submission provided by the proponent. The project start date will be determined with the shortlisted proponent before Award.
- Q2: There is a noted preference that "That Confidential Information be stored, transported, and transmitted ("Sited") in a secure jurisdiction". While is it is subsequently outlined that "siting" in Canada is preferred, under what circumstances would The City consider siting in the US if necessary?
 - A2: Refer to B18.5.2 (b), (c). The proposal should include the proposed alternative jurisdiction if not "Sited" in Canada and the City reserves the rights to assess the proposed alternative jurisdiction.
- Q3: There is a specified dollar figure noted for available funds year 1 costs license, services, etc. How did The City determine this dollar amount? There can be significant return on investment for these types of planning solutions. Since the City generally has a sizable portfolio of investments/infrastructure plans, and there is opportunity for significant savings with the right solution, was this in consideration for the funding allocation?
 - A3: Refer to D3.4, the funds for Year 1 is \$100,000. The City can not disclose any further information.
