## PART D - SUPPLEMENTAL CONDITIONS

Revise: D4.4 to read: The Consultant is required to prepare and administrate up to **three (3)** Tenders.

Revise: D6.3(a) to read: Include ability of snow disposal site to accept 800,000 cubic meters of snow;

Revise: D16.1 to read: The Consultant shall achieve critical stages of the Services for this Contract in

accordance with the following requirements:

(a) Have ready by August 11, 2023:

- i. a temporary drainage design to accommodate snow disposal during the 2023-2024 winter at project D4.1(i) site; and
- ii. final location of approaches along the service road servicing the snow disposal site.
- b) Construction tender must be ready to be advertised on MERX's website by **August 18**, **2023** for temporary drainage under D16.1 (a). The actual advertising dates, corresponding construction contract schedules, and scopes of work for the construction, will be established during the Detailed Design, in consultation with and approved by the Project Manager; and,
  - (i) Substantial Performance for construction contract by October 31, 2023.
- (c) Construction tender must be ready to be advertised on MERX's website by **September 14, 2023** for project D4.1(i). The actual advertising dates, corresponding construction contract schedules, and scopes of work for the construction, will be established during the Detailed Design, in consultation with and approved by the Project Manager; and,
  - (i) Substantial Performance for construction contract by September 30, 2024.
- (d) Construction tender must be ready to be advertised on MERX's website by December 1, 2023 for project D4.1(ii). The actual advertising dates, corresponding construction contract schedules, and scopes of work for the construction, will be established during the Detailed Design, in consultation with and approved by the Project Manager; and,
  - (i) Substantial Performance for construction contract by October 31, 2024.
