QUESTIONS AND ANSWERS

- Q1: In the RFP documents it mentions the vendor should have the ability to integrate with GTFS-Flex, is there a particular vendor the City had in mind? Would a Transit App integration be favorable?
 - A1: This integration capability is specified with a mind to future enhancements. Winnipeg Transit prefers open standards and non-proprietary integrations where possible. There is no particular vendor the City had in mind. A Transit App integration would be beneficial, but Winnipeg Transit has no preference for any specific app.
- Q2: Given the desire for the On-Request Transit to go live no later than August 31, 2023, when is the City anticipating the Notice of Award?
 - A2: The City intends to award before the "Go Live Date" and provide reasonable time for implementation.
- Q3: Could we please have the names of the local contractors?
 - A3: Contracts to deliver Transit Plus service are awarded through the City of Winnipeg's procurement process. All bid opportunities and subsequent award information can be found here:
