QUESTIONS AND ANSWERS

- Q1: Does the City want the successful proponent to attend or witness the FAT for the PLC equipment?
- A1: Yes, please include to attend or witness Factory Acceptance Test (FAT) in pricing for Item No. 5 on Form B: Prices.
- Q2: Can it be assumed that the City will pay for railway crossing agreements, railway crossing permits, and railway required geotechnical reviews by approved service providers (assigned by the railway)?
- A2: Yes, the City will pay for railway crossing agreements, railway crossing permits and railway required geotechnical reviews. The cost for these services will come out of the work allowances identified on Form B or by a separate purchase order created by the City. The consultants cost to prepare the required railway documents will be included in the detailed design fee.
- Q3: D12.2.12 identified several permits and approvals required. Can City confirm that permit costs will be paid by the City?
- A3: Permit costs will be paid by the City.

- Q4: B2. Would the City consider extension to this date, given size of proposal?
- A4: The City would like to keep the submission deadline as April 12, 2023.
- Q5: D10.1.2a and Appendix C identifies 4 land purchases, 8 easement agreements and 3 rail agreements. Does the City have any understanding, or can they provide guidance on expected timelines of such purchases/agreements? This is a significant time risk factor. (identified in D10.6)?
- A5: See RFP clause D10.3, Section 7.0 Easement and Land Acquisitions in the PDR and the PDR project schedule. From the City's understanding, the lift station land location is the most important land acquisition for CentrePort South Phase 1A works. The City has initiated discussions with the Province of Manitoba for the purchase of the wastewater lift station land location. Land agreements will take time and the City is relying on the experience of proponents to finalize the design early on in the project, and plan and schedule land agreement activities.
- Q6: D27 Critical Stages given land purchase, crossing agreement requirements, and volume of work would City consider extending these?
- A6: The City would like to keep the Critical Stage dates as listed in D27. Land agreements will be required before posting of the Construction Tenders.
