## **QUESTIONS AND ANSWERS**

- Q1: Please confirm that 23-C-01 Leila Avenue, includes the section from the CPR track to McGregor St for the eastbound direction. According to the city maps, list of regional Streets in the Manual of Temporary Traffic Control on City Streets and google, the eastbound direction from the tracks to McGregor in the Eastbound direction is designated as Partridge Avenue.
  - A1: The eastbound section of Leila/Partridge from the CPR track to McGregor is included in the project.
- Q2: D3.3 this table shows all Leila works budgeted in 2022. Given this has already been deferred is there a preference or expectation from the City's perspective that Leila Ave construction should be completed first (2024), with McGregor and Partridge construction therefore deferred to 2025?
  - A2: The budgeted year for the Leila work is inconsequential to when the work is completed. The proper phasing of the work can be discussed and agreed upon during the design.
