Revise: D2.1.5 to read: Critical Stage for completion of removal of trees tagged during the previous calendar

year, including invoicing: **May 26, 2023 for the initial term of the Contract and** April 30th **for each extension term.** Date of this Critical Stage may be adjusted in the first year

of award at the discretion of the Contract Administrator.

Revise: D19.1(b) to read: Work Orders issued prior to May 26th, 2023 for the initial term of the Contract and

April 30th **for each extension term** of that calendar year are to be completed on or before **May 26th**, **2023 for the initial term of the Contract and** April 30th **for each extension term** of that calendar year, which may result in Work Order deadline dates being adjusted to accommodate the deadline of **May 26th**, **2023 for the initial term of the Contract** April 30th **for each extension term** as required and as determined by the Contract Administrator, regardless of the issue date. In the event the date of this first Critical Stage requires adjustment in the first year of award, it may be adjusted at the

discretion of the Contract Administrator.

(i) Work issued during this timeframe will be for diseased trees tagged

during the previous calendar year.

Revise: D20.1(b) to read: Critical Stage May 26th, 2023 for the initial term of the Contract and April 30th for each

extension term or in accordance with D19.1(b) in first year of award – five hundred

dollars (\$500);

Revise: E5.6(a) to read:

(i) All Work previewed prior to **May 1st, 2023 for the initial term of the Contract and** April 5th **for each extension term** will be added to a work order on or before this date.
